- Provide advocacy, support, resources, options, and referral services to victims/ survivors of crime, including 24-hour crisis response.
- Maintain collaborative relationships with community partners to encourage victim centered service delivery.
- > Facilitate meetings, provide training and education, and assist with coordination of fundraising and awareness events within local communities.

SUPERVISION EXERCISED: Advocates supervise temporary workers, interns, or volunteers as directed or assigned by supervisor.

JOB SUMMARY:

- > Provides advocacy services in-person and on crisis lines for victims/survivors of crime from diverse backgrounds and life experiences.
 - Provides information on rights, resources, and services available.
 - Assists with obtaining civil protective orders.
 - Explains the criminal justice process and prosecution procedures.
 - Assists survivors of crime in finding resources.
 - Accompanies survivors of crime to appointments, court hearings, hospital exams or law enforcement interviews.
 - Facilitates empowerment groups.
- Records all services provided to victim/survivors of crime. Maintains records of work performed; submits reports as required.
- Is on-call for mandatory crisis line up to 6 weeks throughout the year after regular business hours.
- Serves to assist with communication between youth and systems.
- Facilitates coordinated community response multidisciplinary team meetings in assigned service area.

- Educates and informs the community through social media, social media, presentations, and professional training.
- Attends interagency meetings, trainings, committees, boards, and workshops relevant to advocacy services.
- Hosts local fundraising and educational events with assistance from other team members.
- Participates in agency fundraising events as directed.
- Maintains a clean and client-friendly office.

OTHER RESPONSIBILITIES:

- Participate in a minimum of 12 Hours of continuing education annually.
- > Performs other duties and assumes additional responsibilities as directed by direct supervisor/leadership team.
